



## Response to SRP 2.0 Questions

**Last Updated: May 16, 2023**

Q: How do I complete the measurable outcomes attachment without the template?

A: Measurable outcomes and baselines are not required with the application submittal however both must be developed prior to project kick off. To assist applicants and ensure consistency in the data collected, SCAG is developing an approach to use across the region.

Q: Can I submit a draft application for feedback before the deadline?

A: Yes, you can submit a draft application for pre-review to obtain general feedback and guidance on areas to improve. You can submit your draft materials to [gardea@scag.ca.gov](mailto:gardea@scag.ca.gov).

Q: Are jurisdiction-wide projects eligible for the SRP 2.0 program given the infill definition?

A: SCAG is currently clarifying whether projects including both urbanized and non-urbanized areas, like community plans or jurisdiction-wide projects, are eligible uses.

Q: Will my COG need to re-certify/re-procure our REAP 1.0 bench of consultants for REAP 2.0 work activities?

A: Yes, COGs will need to re-certify with SCAG, though it will be an abbreviated process. You can find SCAG's risk assessment form at <https://scag.ca.gov/post/subregional-partnership-program-20>.

Q: When is the application period?

A: The SRP 2.0 application opened on April 12 and closes on May 31<sup>st</sup> at 5PM.

Q: Can the application period be extended?

A: Yes. The application period can be extended in advance and in writing by SCAG.

Q: When is the expenditure deadline for these funds?

A: The expenditure deadline for our subrecipients is December 31, 2025.



Q: Is application development a reimbursement expense?

A: Yes. In Section 4d of the SRP 2.0 Guidelines, *“SCAG will only reimburse costs beginning on the date of Regional Council approval of the SRP 2.0 guidelines that are specifically associated with program development, such as preparation of the program application, outreach to the subregional partners’ jurisdictions, development of guidelines and other related documents, and development of scopes of work and contracts.”*

Q: Does each proposed project need to meet each of the funding criteria?

A: For purposes of Section 7: REAP 2.0 Funding Criteria of the SRP 2.0 application, you must provide narrative responses for your project list as a whole.

Q: Where can I find the allocation amount for each Council of Government (COG)?

A: You can find the subregional partnership list and respective funding allocations on Page 16 of the SRP 2.0 Guidelines.

Q: Which jurisdictions are included within each subregion for the purposes of SRP 2.0?

A: You can find which cities fall within which COGs on Pages 16 through 22 of the SRP 2.0 Guidelines.

Q: Where do I send my completed application?

A: Email a pdf of your completed application and accompanying attachments to [housing@scag.ca.gov](mailto:housing@scag.ca.gov) with “SRP Application” in the subject line. Drop box link is acceptable.
