5. SB 960 (Wiener) - Transportation Planning Complete Street Facilities

Mr. Francisco Barajas, Senior Legislative Affairs Analyst, gave the committee members a presentation pertaining to SB 960 (Wiener). SB 960 would require Caltrans to consider incorporation of complete streets elements into SHOPP funded projects. Mr. Barajas informed the committee that the bill was amended to give Caltrans the ability to determine when to include the complete streets facilities in capital and maintenance SHOPP projects. Mr. Barajas advised that additional amendments were expected to be published to address the opposition's concerns. Staff recommended a support position on SB 960 given that it aligns with the Complete Streets Strategy outlined in Connect SoCal as well as the 2024 Legislative Platform.

Committee members engaged in a robust discussion. During the discussion, the committee provided comments and raised several questions. Mr. Barajas thanked the committee for their feedback and addressed all comments and questions.

#### **RECOMMENDED ACTION:**

#### **STRATEGIC PRIORITIES:**

This item supports the following Strategic Priority 2: Be a cohesive and influential voice for the region.

#### **EXECUTIVE SUMMARY:**

This report summarizes the Federal Fiscal Year 2025 appropriations bills moving through Congress. At the time of writing this report, the House of Representatives has passed five of 12 appropriations bills and the Senate has not passed any. Congress has until September 30 to pass all twelve appropriations bills, leaving only two weeks for both chambers to pass all 12 appropriations bills. A Continuing Resolution is increasingly necessary to extend the amount of time Congress has to pass budget and avoid a government shutdown.

#### **BACKGROUND:**

Congress reconvened from its August recess on September 9, 2024. At this point, the House has passed only five of 12 appropriations bills, while the Senate has yet to pass any. The House passed Appropriations bills for Military Construction-Veterans Affairs, State-Foreign Operations, Homeland Security, Defense, and Interior-Environment. While the House took an additional vote to consider passage of the Legislative Branch Appropriations Bill in July, it failed by a margin of 205 to 215. Now, the House and Senate will have the rest of the month to pass all twelve appropriations bills before the end of the federal fiscal year on September 30, 2024, or agree to a continuing resolution (CR) to avoid a government shutdown.

As of writing this report, House Speaker Mike Johnson (R-LA) introduced a short-term spending bill that would extend federal funding for six months until March 28, 2025. However, the bill seemed unlikely to pass due to opposition from various members of the Republican party and from the entirety of the Democratic party for many different reasons, including spending levels being too





high or low, funding being extended for too long, and policy riders being attached to the funding bill. Further, the Senate Democratic majority indicated it would not support Speaker Johnson's short-term spending bill, if it did manage to pass in the House and reach the Senate. Thus, it remains extremely unlikely that Congress will pass all 12 appropriations bills by the end of September, and unclear if there will be a short-term spending bill passed in time to avert a shutdown.

An overview and status of House and Senate FY 25 appropriations bills, provided by SCAG's federal lobbyist Holland & Knight, has been attached to this report.

#### **EXECUTIVE SUMMARY:**

The Legislative Tracking Report is provided to keep the Legislative/Communications and Membership Committee (LCMC) apprised of the bills in Sacramento that have a nexus to the Regional Council's adopted Legislative Platform. This report also contains an update on key legislative deadlines.

#### **BACKGROUND:**

SCAG's Legislative Tracking Report serves as a resource for the Committee to remain informed on bills moving through the legislative process in Sacramento. The report tracks 24 measures with a nexus to the Regional Council's adopted 2024 State and Federal Legislative Platform.

The California legislature reconvened from summer recess on August 5, 2024. Legislators worked to pass a flurry of bills during its final weeks of session before they adjourned for the year on August 31, 2024. Governor Newson still has until September 30, 2024, to sign or veto bills passed by the legislature that reached his desk before September 1, 2024.

While the Governor considers the remaining bills on his desk, various bills on which SCAG took a position wait his final action. SCAG took positions on 41 pieces of legislation over the past two-year legislative session, including five "watch" positions, 28 "support" positions, and seven "oppose" positions, as well as one "Hold as Two-Year Bill" position. Four bills on which SCAG took a position are pending action by the Governor, including AB 98 (Gomez Reyes and J. Carrillo) – Oppose, AB 761 (Friedman) – Support, SCR 13 (Roth) – Support, and SB 393 (Glazer) – Support. All other bills have



already been signed into law, died in the legislature, or were vetoed by Governor Newsom. The agency's bill position tracker has been attached to this staff report.

While we wait for the Governor to act on any remaining bills, the legislature is now in recess until January 2025. However, the body will return for a quick organizational session on December 2, 2024, before the 2025-2026 Legislative Cycle begins in January 2025.

#### **RECOMMENDED ACTION:**

Staff recommends that the LCMC forward a recommendation to the Regional Council to adopt a resolution to address the California insurance crisis.

#### **STRATEGIC PRIORITIES:**

This item supports the following Strategic Priority 2: Be a cohesive and influential voice for the region.

# **EXECUTIVE SUMMARY:**

As home and business property owners in the state of California continue to face the impacts from fluctuations in the insurance market, several organizations have passed resolutions asking the California Insurance Commissioner, State Legislature and Governor's office to take immediate action by declaring a state of emergency to implement policies that will address the ongoing crisis. SCAG President Curt Hagman has requested that SCAG join in the advocacy efforts by passing its own resolution likewise calling for emergency action to be taken. SCAG staff is bringing the request before the Legislative/ Communication and Membership Committee (LCMC) with a recommendation that the committee forward a recommendation to the Regional Council to adopt the resolution as it aligns with several key items in our State Legislative Platform.

## **BACKGROUND:**

In 2023, State Farm made national headlines when it announced that it would cease to sell new home insurance policies in California. In the same year, Allstate issued a similar announcement. Together, both insurance companies represent over 27 percent of the insurance market in the state. Additionally, announcements were made by other private insurance companies, representing 36 percent of the insurance market in the state, that they would be limiting new policy originations.

The drop in availability of marketplace insurance policies has subsequently put excess stress on the California Fair Access to Insurance Requirements (FAIR) Plan, a state-established risk pool that was



created to act as a final resort to allow consumers time to continue to shop for alternative insurance plans, not act as a replacement.

To address this growing problem, the San Bernardino County Board of Supervisors passed a resolution on June 25, 2024, calling for California Insurance Commissioner Ricardo Lara, the State Legislature, and Governor Gavin Newsom to take emergency action to strengthen and stabilize California's marketplace for homeowners and commercial property insurance. Additional entities that have likewise passed their own resolutions include the County of Orange, City of Yorba Linda, and the Orange County Council of Governments.

The resolutions identify five policy goals they wish to see accomplished. These include:

- 1. Expand coverage choices for all consumers, particularly in underserved areas of the State.
- 2. Improve the efficiency, speed, and transparency of the California Department of Insurance's rate approval process.
- 3. Tailor the rate approval process to account for all factors necessary to promote a robust, competitive insurance marketplace, including through potential revisions to the way catastrophe risks, reinsurance costs, and other legitimate insurer costs are accounted for.
- 4. Maintain the long-term availability of homeowners and commercial property insurance coverage.
- 5. Maintain the solvency of the FAIR Plan to protect its policyholders and promote long-term resiliency in the face of extreme weather events, including by identifying mechanisms to reduce its share of the overall market in underserved areas and move its customers into the admitted insurance market.

At the request of SCAG President Curt Hagman, SCAG staff is bringing the item before the LCMC with a recommendation that the committee forward a recommendation to the Regional Council to adopt a resolution requesting the California Insurance Commissioner, State Legislature, and the Governor take emergency action to strengthen and stabilize California's marketplace for homeowners and commercial property insurance.

As is noted in the resolution, included in the report for reference, access to insurance not only allows existing homeowners to protect what is most likely their largest and most important asset but empowers homebuyers to secure a mortgage for a home. A scarcity of options may freeze real estate transactions and slow or stop new housing development, which would include affordable



housing projects, apartments, and condominiums. Work to address these impacts aligns with several items in SCAG's board adopted State Legislative Platform, including:

- Item 11 under "Affordable Housing and Housing Production" Support programs and legislation that expand the capacity to preserve both naturally occurring affordable housing as well as affordable housing with expiring covenants.
- Item 5 under "Expanding Economic Opportunity & Economic Development" Support efforts to expand access to homeownership, particularly for first-time homebuyers and communities of color.

In response to the passage of the resolution by the County of San Bernardino, Insurance Commissioner Ricardo Lara issued a statement acknowledging efforts his office is already undergoing to remedy these issues, including the passage of his "Sustainable Insurance Strategy," which he set in motion in September 2023. Several key items noted in the strategy include updating rate review timelines, improving rate filing procedures, and updating risk assessment tools. As such, in his statement, Commissioner Lara recognized passage of the resolution as "support of our urgent on-going regulatory work to solve this insurance crisis and stabilize our state's insurance marketplace that results in more insurance companies returning and expanding in all areas of our state."

While the Commissioner's efforts are acknowledged, the Little Hoover Commission reported in its hearing on March 28, 2024, that these reforms "will not go into effect until at least 2026, and it may take a few years after that for the market to react." For these reasons, the resolution calls for a collaborative partnership between the Insurance Commissioner, the Legislature, and the Governor to take more immediate and comprehensive action.

## **FISCAL IMPACT:**

# **RESOLUTION NO. 2024-94**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, STATE OF CALIFORNIA, REQUESTING THE CALIFORNIA INSURANCE COMMISSIONER, STATE LEGISLATURE, AND THE GOVERNOR TAKE EMERGENCY ACTION TO STRENGTHEN AND STABILIZE CALIFORNIA'S MARKETPLACE FOR HOMEOWNERS AND COMMERCIAL PROPERTY INSURANCE.

On Tuesday June 25, 2024, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS,** in 1988, California voters enacted Proposition 103, which established a robust set of consumer protections designed to keep insurance rates fair and affordable and to ensure a competitive marketplace; and

WHEREAS, last year, two of the State's largest insurance carriers, representing over 27 percent of the admitted insurance market in California, announced they would stop issuing new homeowners and commercial property insurance policies in California; several others, representing more than another 36 percent of the market, announced plans to limit new policy origination; and

WHEREAS, the reduction of insurance options in the State has a direct negative effect on consumer access to coverage: in all parts of the State, homeowners, business owners, and farmers are now unable to obtain new insurance policies from the admitted insurance market; and

WHEREAS, access to insurance allows existing homeowners to protect what is for many their largest and most important asset, and empowers homebuyers to secure a mortgage for a home that can build generational wealth, but a scarcity of options may freeze real estate transactions and slow or stop the rate of new housing development, including attached dwelling units like affordable housing projects, apartments, and condominiums, exacerbating the State's critical housing shortage; and

WHEREAS, Californians who cannot obtain coverage from the admitted market are forced to apply for protection through the California Fair Access to Insurance Requirements (FAIR) Plan, a state-established risk pool intended to operate as California's insurer of last resort providing temporary coverage as consumers pursue insurance in the traditional market; and

WHEREAS, the collapsing admitted-provider market has caused steadily increasing enrollment in the FAIR Plan over the past five years, threatening the ongoing stability of the plan, putting even this safety net at dire risk; and

WHEREAS, policy decisions have placed Californians' homes and businesses at risk of catastrophic loss that can only be prevented by stabilizing the homeowners insurance and commercial property insurance markets while providing rates that remain fair and affordable to consumers, and maintaining the ongoing viability of the FAIR Plan, which provides a vital safety net to Californians whose policies are nonrenewed and to homebuyers who cannot secure a mortgage without insurance; and

WHEREAS, the California Insurance Commissioner has released draft regulations to address this immediate crisis but the Little Hoover Commission hearing on March 28, 2024 reports that reforms "will not go into effect until at least 2026, and it may take a few years after that for the market to react... this timeline, of course could be delayed further if lawsuits by any party, including insurers or consumers, were to occur"; and

WHEREAS, the California Insurance Commissioner has broad authority under the Insurance Code to adopt emergency regulations to promote the public welfare, including under sections 1861.01, 1861.05, and 1861.055 to adopt emergency regulations governing the prior approval process for insurance rate change applications, and to adopt emergency regulations under section 11346.1 of Government Code and section 12921.7 of the Insurance Code.

# NOW, THEREFORE, BE IT RESOLVED BY THE SAN BERNARDINO COUNTY BOARD OF SUPERVISORS, as follows:

**Section 1.** The Insurance Commissioner, State Legislature, and the Governor are requested to declare a state of emergency and take immediate emergency regulatory and legislative action to strengthen and stabilize California's marketplace for homeowners insurance and commercial property insurance. The Commissioner, Legislature, and Governor must consider the following goals in crafting an appropriate regulatory response:

- a. Expand coverage choices for all consumers, particularly in underserved areas of the State.
- b. Improve the efficiency, speed, and transparency of the California Department of Insurance's rate approval process.
- c. Tailor the rate approval process to account for all factors necessary to promote a robust, competitive insurance marketplace, including through potential revisions to the way catastrophe risks, reinsurance costs, and other legitimate insurer costs are accounted for.
- d. Maintain the long-term availability of homeowners and commercial property insurance coverage.
- e. Maintain the solvency of the FAIR Plan to protect its policyholders and promote long-term resiliency in the face of extreme weather events, including by identifying mechanisms to reduce its share of the overall market in underserved areas and move its customers into the admitted insurance market.



# **EXECUTIVE SUMMARY:**

This report provides the Legislative/ Communications and Membership Committee (LCMC) with an update on SCAG's most recent legislative advocacy efforts, including sending an invitation to the Director of the California Department of Housing and Community Development (HCD) to speak at the November 2024 Regional Council meeting, a request for the Legislative Housing Committees to hold a hearing on HCD's California's Housing Future 2040 RHNA reform report, and SCAG's opposition to Assembly Bill (AB) 98 (Gomez Reyes & J. Carrillo).

While some bills have already been introduced, various recommendations based on HCD's report have yet to be introduced and discussed in the capitol. In anticipation of more bills to come, SCAG staff sent a letter to the Director of HCD, Gustavo Velasquez, inviting him to join the Regional Council at its November 7, 2024, meeting to discuss the report and provide an opportunity for a Q&A session.

SCAG Requests the State Housing Committees to Hold a Hearing on HCD's RHNA Reform Report
In August, SCAG sent a letter to the chairs of the Assembly and State Housing Committees requesting that they conduct a hearing to discuss HCD's California's Housing Future 2040: The Next Regional Housing Needs Allocation (RHNA). SCAG made this request to allow for additional public dialogue concerning the report and its many recommendations.

# Assembly Bill (AB) 98 (Gomez Reyes & Carrillo)

Assembly Bill (AB) 98 was introduced by Assemblymember Cecilia Aguiar-Curry (D-Winters) in January 2023, and was initially related to cotton pest abatement districts. On August 28, 2024, in the final days of the 2024 legislative session, Assemblymembers Eloise Gomez Reyes (D-Colton) and Juan Carrillo (D-Palmdale) gut and amended AB 98 to relate to regulations on new warehouse developments or expansions. At the request of Legislative/Communications & Membership Committee (LCMC) Chair Patricia Lock Dawson, technical and legislative staff conducted a thorough review of AB 98 and recommended that the agency oppose the bill. However, since the bill was gut and amended so late in the legislative cycle, the earliest the Regional Council could adopt the LCMC's recommendation to oppose the bill would be on October 3, 2024, which is after the September 30 deadline for Governor Newsom to veto or sign bills on his desk. Thus, staff recommended that the agency oppose AB 98 outside the usual process based on our adopted legislative platform, which contains planks that support using local knowledge for land use decisions and not the state's mandates. Thus, staff proceeded to draft and send a letter to Governor Newsom requesting that he veto AB 98.

# Assembly Bill (AB) 98

**Authors:** Assemblymembers Juan Carrillo (D-Palmdale) and Eloise Gomez Reyes (D-Colton).





**RE:** Prohibits cities and counties from approving new or expanded logistics uses unless

they meet specified standards, requires cities and counties to update their circulation elements to include truck routes, and imposes study requirements on the

South Coast AQMD.

**Status:** Passed the Legislature—pending Action by Governor Newsom.

## **Background:**

• This bill would prescribe various warehouse design and build standards for any proposed new or expanded logistics use developments, including standards for building design and location, parking, truck loading bays, landscaping buffers, entry gates, and signage beginning January 1, 2026.

- This bill would prohibit a city or county from approving the development of a logistics use that does not meet or exceed the standards outlined in the bill.
- The bill would require a city or county to condition approval of a logistics use on a 2-to-1 replacement of any demolished housing unit occupied within the last ten years.
- This bill would require a city or county to update its circulation element by January 2028 to include elements such as identifying travel routes for goods movement.
- The bill would authorize the Attorney General to enforce these provisions, including fines up to \$50k every six months if the required updates have not been made.
- It would require the SCAQMD to deploy mobile air monitoring systems from January 2026 until January 2032 in San Bernardino and Riverside Counties to collect air pollution measurements in nearby logistics use developments.
- SCAQMD would be required to evaluate the impact of logistics-related air pollution on sensitive receptors and submit a report to the Legislature by January 2033, including an interim report analyzing the effects in Riverside and San Bernardino Counties.

RE: REQUEST FOR VETO – AB 98 – Planning and Zoning: Logistics Use

Dear Governor Newsom:

On behalf of the Southern California Association of Governments (SCAG), I write respectfully to request you veto Assembly Bill (AB) 98, authored by Assemblymembers Eloise Gomez Reyes (D-Colton) and Juan Carrillo (D-Palmdale). This bill would threaten the economic vitality of the Southern California region by adding new burdensome and rigid rules to the warehousing and logistics sector, which is vital to our regional economy.

First, AB 98 would require cities and counties to undertake the costly and time-consuming process of updating the Circulation Element of their General Plan with truck route information. AB 98 would require all cities in California to complete this exercise by January 2028 or face fines of up to \$50,000 every six months. However, the bill singles out the 52 cities in Riverside and San Bernardino counties, which would be required to update their Circulation Elements by January 2026 – two years earlier than the rest of the state and only one year after the bill would take effect.

Additionally, AB 98 would require mobile air quality monitoring stations with a report to the Legislature on air quality modeling in Riverside and San Bernardino Counties. While SCAG is not opposed to the required data collection, AB 98 fails to take an overall supply chain approach. Because AB 98 does not make any distinction between distribution and fulfillment facilities versus retail and wholesale locations, the information would be incomplete. This flaw is likely a reflection of the fact that many stakeholders with experience in and an understanding of the complexities of the global freight system were excluded from negotiations surrounding the bill's provisions.

Third, AB 98 fails to recognize that freight growth is a by-product of household growth. SCAG's research has identified an extremely high correlation between population, housing, and industrial square footage growth. Only recently have both housing and industrial square footage growth crossed above population growth as household sizes have marginally declined from the region's peak in 2013. The strong correlation between housing and industrial square footage growth is an important indicator of how tied housing growth and household consumer spending align with industrial support for the distribution and fulfillment of these localized trends. This supports the premise that localized consumption is an important factor and contributor to increasing industrial square footage. It is also an important factor to justify the need to further distinguish between the localized and national consumer trends driving this industrial growth, including the shifts of major metropolitan regions growing into megaregions. If California restricts this growth by further increasing costs to do business, the industry will relocate to more cost-competitive markets, such as Southern Nevada, Maricopa County, Arizona, or Mexico, to name a few.

Lastly, there will be unintended economic impacts resulting from AB 98, not only for the Inland Empire but broadly across the entire SCAG region stemming from the highly complex nature of the global-national-state and regional-local supply chain relationships. If discretionary cargo continues to go elsewhere, there will be job implications beyond distribution and fulfillment centers, including manufacturing, retail, construction, and more, as many of these industries are interconnected.

The warehousing and logistics sector imposes environmental and health burdens on surrounding communities, but local communities also benefit from business and employment opportunities generated by goods movement industries. Finding the balance between these two imperatives is the purpose of the legislative process. This is why SCAG urges legislation of this magnitude to be done with broad-based stakeholder participation so that all concerns may be heard and properly addressed.
