Building off NCHRP Research Report 1044 (2023), that included critical input from SCAG’s planners and modelers, and an FHWA technical assistance effort, SCAG has developed a tool to implement planning-level safety models that will help include safety in scenario and long-range planning.

For decades, SCAG has administered household travel surveys to gather detailed information on household socio-economic characteristics and travel behaviors of residents in the SCAG region. In partnership with LA Metro, SCAG is

currently conducting a multi-year regional household travel survey, known as SoCal Transportation Study, to support planning and modeling needs for the 2028 SCAG RTP/SCS and beyond. This presentation aims to introduce the project background, schedule, and key methodology as an initial information sharing session.
